At the outset Shri Pallav Gopal Jha, IAS, Secretary to the Govt. of Assam, SJ&E Dept. welcomed all the members present.

Director, Welfare of SC & BC, Assam made a presentation on Pre & Post – Matric Scholarship Schemes for SC & OBC Students.

Director, SJ&E, Assam appraised all members present regarding the schemes "Pre & Post – Matric-Scholarship for Students with Disabilities" along with the eligibility criteria and amount of scholarship.

The following decisions were taken:

- Shri Pallav Gopal Jha, IAS, Secretary to the Govt. of Assam SJ&E Dept. requested Director, WSC&BC, Assam to prepare a flow chart showing the different categories of scholarship along with the eligibility criteria, scholarship amount, process for application for convenience of students for applying in Pre & Post Matric Scholarship Schemes for SC & OBC Students scholarship in NSP. (Action to be taken DWSC&BC, Assam).
- Pre-Matric Scholarship for SC Students of Parents/ Guardians Engaged in Unclean Occupation (Class 1 to 10) (Component-II) being a scholarship for children belonging to parents engaged in unclean occupation it is necessary to generate awareness amongst such people and hence communication is to be made to Director, Municipal Administration to convey the information regarding the scholarship scheme so that all eligible students can avail the benefit of scholarships. (Action to be taken – DWSC&BC, Assam).
- To ensure that all eligible SC & OBC students apply in the NSP portal and avail the benefit of Scholarship, a database is required, where details such as Name of the District/ Name of the Institution/ Total SC students/ Total OBC students/ Annual Income of Parents/Guardian below Rs.2.5 lakhs is required to be generated so that the institutions and students can be reached. (Action to be taken Directors: Technical/ Medical/ Higher/ Secondary/ Elementary Education).
- Smti. Dipika Choudhury, AES, Deputy Director, Secondary Education shall be the single point of contact for obtaining report in respect of Pre & Post – Matric Scholarship Schemes for SC & OBC Students of Education Department irrespective of Education Directorates.
- To understand the problems faced by students during application in the NSP portal as well as to understand the less number of applications received, a feedback from students is to be taken so that the issues can be addressed and all the eligible students are benefited through the scholarships schemes. (Action to be taken – Directors: Technical/ Medical/ Higher/ Secondary/ Elementary Education).
- An SOP for Institute Nodal Officer (INO) is to be prepared to assist the Institute Nodal Officer (INO) during verification. (Action to be taken – DWSC&BC, Assam)
- It was decided that, a monthly meeting will be held to review the status of Pre & Post Matric Scholarship Schemes for SC & OBC Students.
