**NOTIFICATION**

In view of the recent declaration of results of CBSE compartmental Class X Examination, 2025, it is hereby notified to all the concerned that the online admission portal "DARPAN" will be re-opened for submission of applications for Admission of IIS 1<sup>st</sup> Year Class for session 2025-26, from **13<sup>th</sup> August, 2025 to 16<sup>th</sup> August, 2025**.

Since, this office is in receipt of good number of applications for allowing transfer of students of class XI to other institution, the transfer of eligible students to other institution is also allowed from 13<sup>th</sup> August, 2025 to 16<sup>th</sup> August, 2025. However, in case of transfer of students from one institution to other institution, the maximum allowable limit is two students between any two specific institutions. In case of receipt of request for more students, the ASSIEB, DIV-II reserves the right of cancellation.

All eligible students are, therefore, requested to visit the official website of ASSIEB, DIV-II [www.ahsec.assam.gov.in](http://www.ahsec.assam.gov.in) or <https://darpan.ahseconline.in> for further information and to apply for admissions in IIS 1<sup>st</sup> Year Class, invariably within the time frame as given below. It is to be noted that the institutions will be able to conduct the admission simultaneously.
